



SUMMERVILLE CATHOLIC SCHOOL 2010/2011 TUITION and FEES

REGISTRATION FEE: To reserve a space for your child, this fee is due at time of registration.
 Prior to March 1, 2010 - \$175.00 per student/\$350.00 maximum per family
 March 1, 2010 or later - \$200.00 per student/\$400.00 maximum per family

The following fees are due to the school by April 30, 2010. If not received by then, an administrative fee of \$25.00 will be added and the unpaid fees will be added to your FACTS account and collected in May and June 2010.

CAPITAL IMPROVEMENT FEE:

By April 30, 2010: \$150.00 for returning families; \$500.00 for new families
 May 1, 2010 or later: \$175.00 for returning families; \$525.00 for new families

TUITION is determined by number of children attending SCS and whether or not the family is a member of a supporting parish. To receive the parishioner rate, a family must be registered at one of the following parishes: Immaculate Conception, St. Ann at Santee, St. Anthony of Walterboro, St. John the Beloved, St. Theresa the Little Flower or St. Thomas the Apostle and must be an active, participating family which supports the parish financially through regular use of envelopes. Each year, proof of parishioner status (Parishioner Rate Verification Form) must be signed by the church and presented to the school by the family at the time of registration.

PAYMENT OPTIONS:

All payments will be made to FACTS Management Company at a cost of \$41.00 per account. The Payment options available are:

1. Pay tuition **in full** by **July 5, 2010** and receive a 3% discount.
2. Pay **half** the tuition by **July 5** and **half** by **December 5**. No discount applies.
3. Pay **monthly** (10 payments) beginning **July 2010** through **April 2011**.
4. **Unpaid fees** as of May 1, 2010 will be collected through FACTS in May and June 2010.
